## Limited Warranty Policy

All items repaired or overhauled by Aviation Instrument Service International, Inc., will be covered under warranty for Ninety (90) days beginning on the date of shipment to the customer or five hundred (500) hours of operation, whichever occurs first.

To expedite warranty consideration, we request that the item be returned with the following information; Date installed, aircraft installed, time in service, date of fault and date removed from service.

Warranty will not apply to any item that exhibits improper storage, improper installation, misuse or mishandling, damage physically or electrically, accidents or items returned with torn missing, damaged seals or lockwire.

If a warranted faulted is covered during the warranty period, it shall retain only the unused portion of the original warranty, in period of time or hours of operation. When repairs are made in addition to a warranty repair, that new area of repair will be treated as a new repair and warranty will begin when the unit is shipped.

Repair or replacement of a defective unit pursuant to this warranty shall be made at our facility only, provided the unit is returned and the fault is verified. If the customers reported fault is not confirmed or the fault is not the area of pervious repair, warranty will not be considered applicable. Inbound shipping, outbound shipping and related expenses will be customer liability.



Exception to this warranty of articles or materials furnished will be fuses, lamps, batteries and customer supplied articles or materials.
